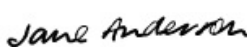

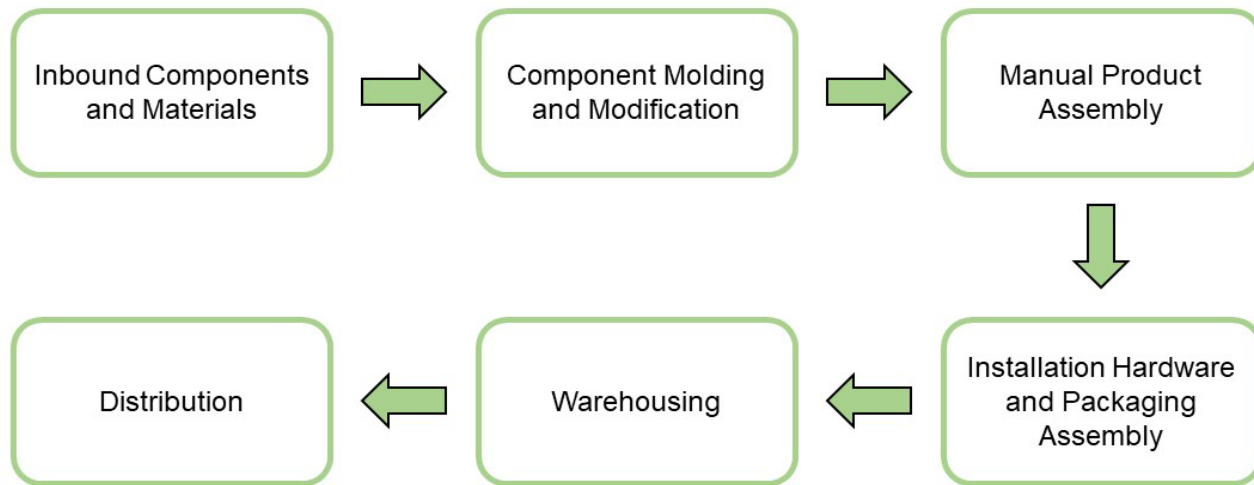

LCA for Experts developed by Sphera was the LCA software used for the study. Primary data were collected for every process in the product system under the control of ASSA ABLOY Corporate. Secondary data from the LCA for Experts Sphera database were utilized. These data were evaluated and have temporal, geographic, and technical coverage appropriate to the scope of the Builder's Hardware product category.

Cut-off Criteria:

Processes whose total contribution to the final result, with respect to their mass and in relation to all considered impact categories, is less than 1% can be neglected. The sum of the neglected processes may not exceed 5% by mass and by 5% of the considered impact categories for each module. For that a documented assumption is admissible. Product Use

The product is possible to reuse during the reference service life and can be moved from one similar door opening to another. No auxiliary or consumable materials are incurred for maintenance and usage of the product. Repairs or replacement are not usually necessary. No cleaning efforts need to be taken into consideration. The use phase covers the 10 year service life of the product using a European electricity grid mix. This product was in on mode 0.01 hours out of the day for 365 days out of the year and uses 0.192 W per on-mode and 0.000036 W while on stand-by.

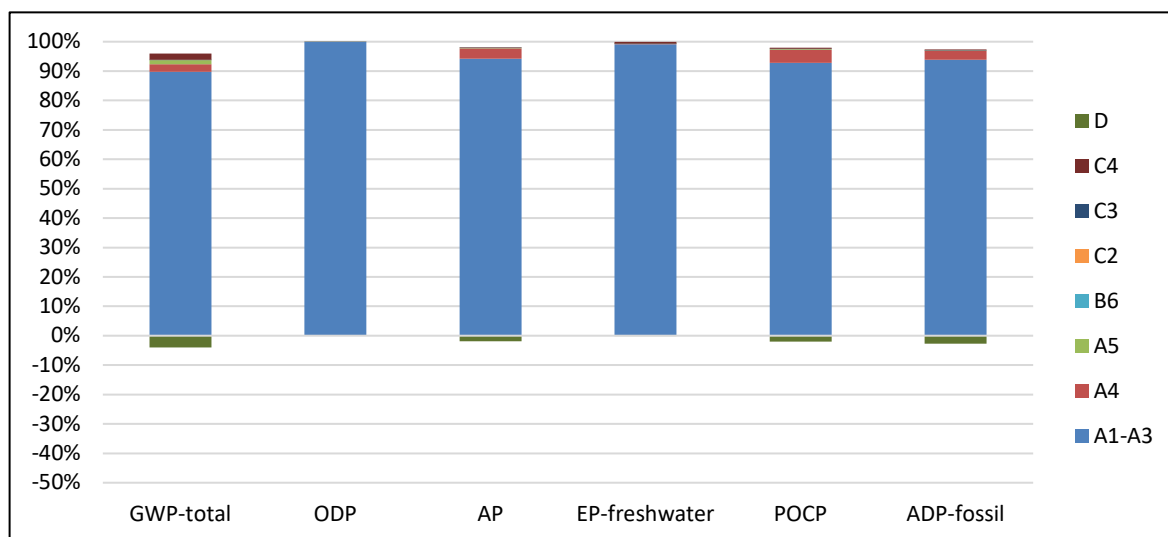
